



Photography Policy

We are very proud to share the beauty of our Italian-inspired Village with the community. The Village is private property, with public access and is designed to provide our residents, tenants and customers a safe, friendly and comfortable place to shop, dine and enjoy the amenities. We will allow use of the common area of the Property only for activities that are a direct benefit to the Property and its tenants. You are welcome to take photographs of friends and family in the common areas at The Village for personal and non-commercial use. Posed photography such as family portraits, wedding photos, by anyone acting as a photographer for compensation must be approved by Village management prior to any scheduled shoot for a flat rate of \$50 per experience, which is typically no longer than two hours. Longer shoot times may require a separate agreement, insurance and additional fees. Please contact the management office for the appropriate paperwork and to make payment. Advance notice is required. Photography of Village events, performers and architecture are not permitted without permission from Village management office prior to shooting. The Village reserves the right to refuse any photography requests at its discretion.

RELEASE AND WAIVER OF LIABILITY, AND ASSUMPTION OF RISK AND INDEMNITY AGREEMENT
